

HOW TO FINANCE AN AIRCRAFT

Applying for a Loan through AirFleet Capital
A Step-by-Step Outline

Step 1:

Preparing your Application Package Our goal is to provide you with the fastest possible turnaround and we need your help to accomplish this. We will need a complete application package with all of the requested detail and supporting financial documents as listed below:

Please note the information we need in order to complete our underwriting:

You / Guarantor / Co-Borrower

- Application and Personal Financial Statement (PFS).
 Signatures /dates needed at the bottom of each form.
 You may also provide your own PFS in lieu of our template.
- If your credit reports are frozen / locked you will need to unlock all of them for 48 - 72 hours.
- Most recent cash, brokerage, and retirement account statements (include all pages showing name, date and balances)
- 2 Years Federal Tax Returns including schedules, W-2s and K-1s. 3 Years for loans \$1Million+
- Current Paystub
- IDs driver license (front and back) and either pilot certificate or passport
- Aircraft Specification or link to online listing

Business(es) you Own

All information listed to the LEFT (we require a personal guaranty therefore personal information is required) PLUS:

- 2 Years Federal Tax Returns including schedules and K-1s. 3 Years for loans \$1Million+
- Interim Financials (P&L and Balance Sheet) management-prepared or CPA-prepared
- Verification of Corporate liquid assets
- o If available, 2 Years CPA-Audited or Reviewed financials with notes. 3 Years for loans \$1Million+

Step 2:
